The Customer shall have the right to terminate if any changes are not acceptable.

OUR SERVICES TO YOU UNDER THIS AGREEMENT

1. It is mutually agreed that this policy covers only **ONE FREE ANNUAL INSPECTION** inside the residence as listed on Home Equipment Survey/Checklist.
2. **Petri Plumbing Heating, Inc.** shall not be responsible for system design or performance in maintaining design conditions. Our normal working hours are (Monday thru Friday from 8:00 a.m. to 5:00 p.m.)(Saturday 8:00 a.m. to 1:00 p.m.). We provide 24 hour phone service.
3. The homeowner cannot assign or transfer this agreement without notifying **Petri Plumbing Heating, Inc.** of the name change.
4. Any changes, adjustments or repairs made by others, unless authorized or approved by **Petri Plumbing Heating, Inc.**, shall terminate its obligation hereunder.
5. **Petri Plumbing Heating, Inc.** will endeavor to render prompt and efficient service hereunder, but it is expressly agreed that **Petri Plumbing Heating, Inc.** shall in no event be liable for damage or loss caused by delay or any loss arising out of performance of this agreement.
6. **Petri Plumbing Heating, Inc.** reserves the right to reject any policy if an inspection by our service technician finds evidence of a competitors service sticker on any equipment covered by this agreement.
7. This agreement contains the entire understanding between **Petri Plumbing Heating, Inc.** and the Customer. Any modifications, amendments or changes must be in writing and signed by both parties.
